COFANET OPTIMIZATION IN A NUTSHELL (1/2)


Context

- CofaNet, Coface's online credit management system, was fully redesigned in 2017
- Following this launch, some of our clients and brokers pointed a "complex interface browsing"
- As a consequence, we decided to review the key ergonomics of our interface, while keeping the overall spirit of the 2017 redesign
 - Selection of a web design agency
 - Clients and Brokers involvement during the screens redesign (online qualitative testing sessions)


• Key features

- New features allowing the client to easily find his way in the interface (creation of a homepage, onboarding assistant)
- <u>Access simplification</u> to the most frequently used functionalities, namely: Credit Insurance or Information products requests, Claims declaration
- <u>Redesign</u> of some classic features for improved clarity: Company search, Navigation bar, Risk Portfolio layout, Notification center layout, Buyer's page




COFANET OPTIMIZATION FOCUS ON... THE HOMEPAGE






COFANET OPTIMIZATION FOCUS ON... THE 'STEP BY STEP' PRODUCT REQUEST


